We got very close but our reauthorization bill did not make it to a vote to pass in Congress in 2010. I greatly appreciate the help of our Congressional delegation and their staff during this process. I especially thank Congressman Rick Larsen for sponsoring the bill in the House, where it passed Committee and full House vote. Senators Murray and Cantwell were tremendously helpful, sponsoring it in the Senate and working it through committee. I will continue to work with our delegation for reauthorization in

the new Congress.

In the meantime, we are looking forward to continued excellent work by our seven Marine Resources Committees and on regional projects managed by the Commission. We will do more public outreach on ocean acidification to better understand this pressing issue. We will continue to grow our Forage Fish Program to better understand the role that these species fill in the region's marine food web. The Derelict Fishing Gear Project will continue as funding allows.

Many thanks to all who participate on our MRCs to conceive great projects, understand what it takes to get them done and then actually make things happen. It is because of you that we can exist at all.

ISLAND MRC MEMBER REMOVES CREOSOTE LOGS FROM HIS BEACH

When Island MRC member Ken Urstad looked out onto his community beach near Greenbank Farm on Whidbey Island this summer, he was dismayed by all the creosote logs and treated lumber that had washed up on shore. For the past three years Ken has been in charge of helping rid Whidbey shorelines of creosote logs, working closely with WSU Beach Watcher volunteers, the Department of Natural Resources (DNR), and the Northwest Straits Commission. Ken helped in the removal of over 700 tons of this debris in the past few years, and understood that DNR was facing severe budget cuts and could probably not afford the crews and helicopters that they have used in the past. Yet he did not want to leave those highly-toxic logs on the beach, as he understood how many dangerous chemicals they contained, and how they affected the marine life around them. MEMBER SPOTLIGHT: AL BERGSTEIN, JEFFERSON MRC

Jefferson MRC member Al Bergstein's interest in environmental issues goes back to the 1970s when he volunteered as a publicity director for Seattle Audubon. His career path spanned computer sales - back when personal computing was a fledgling industry - into work on the technical side that included twelve years with Microsoft. But this self-described "geek" didn't limit himself to the technical world: he's one of those rare people who understands what's under the hood of computers while also having an artistic and social side.



Al was an actor and DJ in his early years, followed by photography, a decade of extensive sailing the Puget Sound region, filmmaking and music. A serious amateur musician ([check him out in the quartet at our 2010 MRC Conference!](#)), he enjoys playing Brazilian music and jazz, and serves on the board of [Centrum](#) in Port Townsend. He's an avid filmmaker, and has acquired the skills and equipment to create high quality projects, such as the [Voices of the Strait](#) production that documents life on the Strait of Juan de Fuca over the last 80 years.

Inspired in part by the Dalco Passage oil spill in 2005, Al looked around for ways to get involved with environmental issues again. He joined the board of [People For Puget Sound](#), where he continues to serve, and started an [environmental news web site](#) for the Olympic Peninsula. Al also participates on the board of the Puget Sound Partnership's Strait Ecosystem Recovery Network and in their Education, Communication and Outreach Network.

All this might be enough for some, but Al also joined the Jefferson MRC early last year. He appreciates the perspectives of fellow members and the opportunity to educate other audiences around important issues using tools like youtube.com, and to take on projects that wouldn't otherwise get done. And he appreciates the "intense discussions" that lead to better understanding and improved policies around marine issues. Most importantly, Al recognizes that everyone is participating because they care and want to do the right thing.

FOUNDATION COMPLETES STIMULUS-FUNDED DERELICT FISHING NET REMOVAL PROJECT



The Foundation completed its stimulus-funded derelict fishing net removal project in December, completing the last of the surveys on New Year's Eve. A total of 783.5 derelict fishing net removal days and 81.5 survey days were accomplished over the eighteen month project period by our four removal and survey vessels. The *R/V Surveyor* crew removed 342 nets over 141 work days, and conducted most of our surveys; the *F/V Twila Dawn* crew removed 433 nets over 155 days; the *F/V Tenacious* crew removed 603 nets over 172 days; the *F/V BetSea* crew removed a whopping 1,139 nets over 311 days. A total of 2,493 nets were removed. More than 140 entangled derelict pots were also removed.

Over 232 acres of critical marine habitat was restored by removing these nets. In them were more than 139,000 animals, including 12 mammals, 153 birds, 756 fish, and 138,444 invertebrates. Using a catch rate model developed by researchers at the University of California-Davis using our data, we can estimate that these nets were entangling more than 1.5 million animals every year, or 4,149 animals daily. The unseen death and destruction caused by these nets is now eliminated forever. [Click here to read the press release.](#)

The Northwest Straits Foundation launched its first ever general appeal in December 2010, to kick off the Campaign for Matching Funds for the Derelict Gear Removal Project. Special thanks to the Kongsgaard-Goldman Foundation for its generous campaign kick-off grant, and to the Puget Sound Anglers regional and state groups for their significant contributions.

WASHINGTON SEA GRANT 2011 REQUEST FOR PROPOSALS

Washington Sea Grant (WSG) requests proposals for one- to two-year research projects from investigators at academic and research institutions throughout the state of Washington.

Approximately \$2.4 million will be available over the next funding cycle (February 1, 2012 - January 31, 2014) to support an estimated 10-15 projects that are selected on an open, competitive, peer-reviewed basis. Preliminary proposals are due at 5:00 p.m., March 7, 2011 and the full proposal deadline is 5:00 p.m., May 23, 2011. All investigators must use eSeaGrant, the WSG online proposal submission system. 2011-2013 MRC GRANTS

Full proposals for 2011-2013 grants to the Marine Resources Committees are due by March 28, 2011. FEBRUARY MESSAGE FROM THE DIRECTOR

The Northwest Straits Commission celebrates 12 years of protecting and restoring the marine resources of the Northwest Straits region. In this time, we've proven that the "experiment" of empowering local residents to tackle tough local issues is an approach worth taking. As we put together our work plan for 2011, the funding outlook is highly uncertain. We have much work yet to do to ensure that our marine waters are healthy and resilient to future threats. We are a lean organization that leverages the energy and enthusiasm of committed volunteers to accomplish significant results – the perfect fit for lean economic times. As we bring together Commissioners for our annual budget session next week, we will be looking to identify new funding opportunities and means to keep moving forward.

MRC PROJECT HIGHLIGHTS



December marked the end of the third quarter of the current MRC grant cycle, and in January the reporting on all that work came rolling in. The results are impressive, and include: installation of a plant-based stormwater filtration system, protection of eelgrass in Port Townsend Bay for the seventh boating season, the documented natural recruitment of native oysters planted in Fidalgo Bay, documentation of fish use in the Elwha nearshore prior to removal of the dams, contact with thousands of residents and visitors through outreach events and workshops, planting of native vegetation to improve salmon habitat, progress on marine stewardship areas, and much more.

More than 6,000 volunteer hours were contributed by MRC members and other community volunteers in support of MRC projects in the last six months. Current projects of the MRCs and their partners have leveraged over \$2 million in other funding. Thanks to all of you who have contributed to this amazing work!

FORAGE FISH NEEDS ASSESSMENT WORKSHOP



In an effort to identify major information gaps and actions needed to protect forage fish, the Northwest Straits Commission and SeaDoc Society recently brought together 25 scientists and managers working in Washington state and British Columbia to catalyze conversation in support for a transboundary collaborative effort. Discussions focused on six species: Pacific herring, sand lance, surf smelt, eulachon, Northern anchovy and Longfin

smelt. Workshop participants were asked to identify actions that would help advance conservation and recovery of these six species in three categories: science, management/policy, and education/outreach. [A full summary of the workshop is now available online.](#)

IN MEMORIAM: JERRY LARSON

The Whatcom MRC lost a dear friend on January 27 with the passing of Gerald “Jerry” Larson. Jerry served as a member of the MRC for 10 years, completing his final term in 2010. He was a gentle yet strong advocate for clams, oysters, salmon, and any critter that kept community members visiting and respecting the beach. His geographic passion was centered in Birch Bay, but he fought for clean water and access to marine resources throughout Whatcom County.

Jerry initiated the MRC’s successful clam surveys, which have introduced hundreds of residents to their backyard bivalves. He volunteered as a water quality monitor and devised and implemented a plan to install “clam tents” in Whatcom County to nourish the native clam populations. I once asked a fellow party-goer who lived in Birch Bay if she knew Jerry. Her response said it all: “I think so. Is he the white-haired gentleman who I see walking the beach picking up litter?” It’s no surprise that she would know him as a selfless community member striving to keep the beach clean and healthy.



We shared Jerry with various organizations, including the Birch Bay Watershed Aquatic Resources Management Advisory Committee, the Nooksack Salmon Enhancement Association, the Drayton Harbor Community Oyster Farm, and the Sons of Norway. Many people will miss Jerry’s smile, demeanor, leadership, and determination. Let’s continue to fight for a healthy environment in his honor. As he always said, “The reward for clean water is a safe and healthy shellfish harvest!” And he meant it, even though he secretly didn’t like to eat the oysters he very much loved to protect.

FOUNDATION RECEIVES FUNDING FOR OLYMPIA OYSTER RESTORATION



The Foundation has been awarded funding from the National Fish and Wildlife Foundation Shell Marine Program to implement a multi-faceted project aimed at restoring Olympia Oysters in North Puget Sound. The initial project team includes members of the Skagit and Jefferson MRCs, and staff with Washington Department of Fish and Wildlife and the Puget Sound Restoration Fund. The project will include genetic analysis and

monitoring of known oyster populations, surveys for unknown remnant populations, restoration-grade seed production and out-planting of seed.

15TH ANNUAL SOUND WATERS UNIVERSITY



The 15th annual Sound Waters 'one day university' was held in Langley on February 5 with several hundred people in attendance, including many MRC members. A great keynote presentation was delivered by Dr. Rick Keil, professor with the University of Washington's School of Oceanography and Fleming Fellow for Ocean Education. Keil, his students, and several volunteers have embarked on a unique way to study connections between people and Puget Sound by tracking the flow of benign, everyday compounds such as spices, coffee and chocolate from supermarket shelves through our stomachs out to the marine environment.

The event hummed with activity, with 60 classes offered on topics such as marbled murrelet biology and organic gardening; and human population growth, climate change, and earthquakes. Among other interesting facts shared by Caroline Gibson, who represented the

Commission: a modest oil spill can have disproportionately greater impacts on marine life than a major one if it happens in the wrong place at the wrong time; and the Seaglider, a deep-diving rocket-shaped glider that collects oceanographic data is first tested in Port Susan Bay before being launched for exploration in the open Pacific and around the world's oceans. Sound Waters is sponsored by the WSU Beach Watchers Program in partnership with Island County MRC and several other entities.

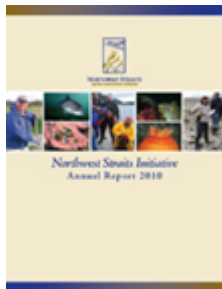

NORTHWEST STRAITS INITIATIVE 2010 ANNUAL REPORT



Hot off the press! **The Northwest Straits Initiative's 2010 Annual Report** is now available. We enjoyed an incredibly productive year in 2010 and we're excited about future projects. Highlights include the completion of our large derelict fishing net removal project, which brought us very close to our goal of removing all the derelict fishing nets (legacy nets) from Puget Sound by 2012. The Commission also expanded its work on forage fish in the region in 2010.

Every Marine Resources Committee is working on a variety of important projects that continue to create a healthier marine environment for all of us – more than 55 projects altogether. SECRETS IN THE SOUND

TRANSBOUNDARY DERELICT GEAR REMOVAL PROJECT

The crew of the F/V Bet-Sea removed a derelict purse seine and 218 derelict crab pots from Canadian waters in February, in the first-ever transboundary derelict fishing gear removal project. The purse seine was removed from waters off of Pender Island, and had been derelict for more than 20 years. Removal crews worked at depths of 80-100 feet in high currents. Rockfish and other animals were found entangled in the net, indicating that long-term impacts on priority species may be significant.



The derelict crab pots were removed from Boundary Bay, just north of the international border. More than 900 pots were found during earlier surveys, but funding allowed for just four days of removal operations. Our crews set a new removal record of 53 pots per day because the derelict pots were so densely packed on the seafloor. More than 100 Dungeness and red rock crabs were found trapped in the pots.

The Foundation worked with funding from British Columbia's Ministry of the Environment and Parks Canada. Hopefully this project will help British Columbia jump start a derelict gear removal program by demonstrating that gear impacts in Canadian waters are comparable to those in Puget Sound. ANNUAL RETREAT BRINGS COMMISSIONERS TOGETHER

SAN JUAN MRC – 7TH ANNUAL MARINE MANAGERS' WORKSHOP

The San Juan Marine Resources Committee held its 7th annual Marine Managers' Workshop on February 28 and March 1 at the University of Washington Friday Harbor Labs. Representatives from more than fifty federal, state, and local organizations from the US and Canada met to share information about their work in the San Juans and Gulf Islands. Presentations and discussion focused on oil spill preparedness and response, new programs to manage growth impacts in the San Juans and Gulf Islands, research on threats to southern resident killer whales, and an assessment of juvenile salmon use of nearshore habitat in the San Juan Islands. Planning ahead, the 2012 workshop will provide a more in-depth session on transboundary issues related to oil spills. The 2013 workshop will showcase programs, resources and approaches for managing growth in island communities.

JEFFERSON MRC – MAYNARD BEACH PROJECT

Jefferson MRC is expanding its work in nearshore and drift cell restoration to include Maynard Beach, at the head of Discovery Bay adjacent to the MRC's Olympia oyster study site. The property extends to the estuary of Snow Creek. Salmon and Snow Creek enter the head of Discovery Bay within a half mile of one another and form the estuary complex that transitions to the bay at the project site.



The project area has been significantly impacted by human activities over the past 130 years, including the installation of a railroad line, now abandoned, that alters tidal hydrology and sediment transport processes in this part of Discovery Bay. The MRC is partnering with North Olympic Salmon Coalition to remove armoring along the old railroad grade, restoring the entrance to a small lagoon by removing a creosote trestle bridge and creating a pocket estuary by replacing a culvert with a larger inlet and bridge.

JEFFERSON MRC LOSES A MEMBER AND A VOLUNTEER EXTRAORDINAIRE



We regret to announce the loss of Jefferson MRC member Steve Lewis, who passed away on February 11. Steve will be fondly remembered as an avid boater and member of the U.S. Coast Guard Auxiliary, who sang sea shanties and told tall tales while skippering his boat through several seasons of volunteer work on various projects in the community. He was a member of the Port Townsend Yacht Club, and held a bachelor's degree in biology from Harvard College. Following six years' work in the Oceanography Department at the University of Washington, Steve taught sailing and powerboat skills, navigation and piloting to the general public for nearly three decades.

In seeking appointment to the MRC, Steve said: "I can well-represent recreational boating interests, with some understanding of the biology and physical complexity of our impact on the marine environment." What he didn't say is that he would loan his boat, the Coaster, for eelgrass marker buoy retrieval and installation, tirelessly volunteer his time and skills for annual rigging of the buoy tackle, and cheerfully staff the MRC's booth at the annual Wooden Boat Festival. Just two weeks before his death, Steve hosted a get together of MRC Eelgrass Committee members at his shop, to teach splicing, pass on his rigging skills and knowledge, and share a few songs. Northwest Commission Highlights

SNOHOMISH OIL SPILL PREPAREDNESS & RESPONSE PROJECT

Kathleen Herrmann, staff for Snohomish MRC, and Andrea Kunz, [UW Program on the Environment](#), presented to the Commission on the recently-completed Snohomish County Oil Spill Preparedness and Response project. The goal of the project was to inform Snohomish County government about the threats and potential impacts of marine oil spills on social, environmental, and economic interests in the County, and to identify and develop prevention and preparedness options for reducing the risks and consequences of marine oil spills. TRIBAL PROJECTS FUNDED

In response to the Commission request for proposals, which closed March 1, project proposals were received from the Stillaguamish Tribe, Swinomish Tribe, and Lummi Nation. After gathering additional information from the applicants and ranking the proposals, the evaluation team recommended funding the Stillaguamish Tribe for ocean acidification monitoring in Port Susan Bay; and the Lummi Nation for two beach clean-ups that will involve tribal members and local schools.

Northwest Straits Foundation Update

\$4.6 MILLION DERELICT FISHING NET REMOVAL PROJECT COMPLETE

The final report for the [American Recovery and Reinvestment Act](#) Derelict Fishing Net Removal Project was submitted to [NOAA](#) at the end of March. The report includes new maps depicting where species impacts were greatest around Puget Sound for different animal groups. Based on our surveys, approximately 953 derelict nets remain in shallow sub-tidal high-priority areas in Puget Sound, with an estimated removal cost of \$1.8 million. OIL SPILL BILL PASSES STATE LEGISLATURE

[House Bill 1186](#), sponsored by Rep. Christine Rolfes (Bainbridge Island) and Rep. Zack Hudgins (Tukwila), will strengthen requirements for stockpiled spill-response equipment, expand the state's drill response program and increase response capacities by training and equipping commercial fishermen. The amended bill passed by the Senate this month requires the Department of Ecology to update requirements on oil companies and other vessels to stockpile state-of-the-art spill response equipment. The bill addresses key deficiencies in the state's oil spill response program detailed by the state's Oil Spill Advisory Council.

2011 SALISH SEA SCIENCE PRIZE

UPDATE: DEEP WATER SAND LANCE PROJECT



On a recent calm and misty day, Caroline Gibson joined scientists Tina Wyllie-Echeverria, Dan Penttila and Anja Kleintech aboard the Friday Harbor Labs R/V Centennial, for their 9th monthly trip to sample Pacific sand lance in deep water. Using a bottom grab, the group collected a dozen sediment samples from previously mapped sand wave fields off San Juan and Lopez Islands. The contents were emptied into large tubs where they sorted through the sand, gravel and shell hash to find any living creatures. As predicted, far fewer sand lance were caught this day than during winter months - the fish have moved up from the bottom into the water column to feed.

Sand lance spawn along our beaches, form huge schools that fuel resident and migratory wildlife, and burrow lightning-fast into the seabed. The deep water project, led by Dr. Wyllie-Echeverria and Dr. Gary Greene, with funding from the Northwest Straits Commission, is garnering attention from scientists in other regions. To date, the bulk of data on sand lance in Puget Sound - including surveys by MRCs – hails from studies in the intertidal and shallow subtidal zones. Specimens collected from 100'- 300' depths are undergoing genetic and other analyses, including friction and adhesion of the fishes' skin as related to their ability to burrow in coarse sediments. The project will be presented to the Commission and at the [141st Annual American Fisheries Society](#) meeting this September.

REAUTHORIZATION BILL INTRODUCED IN CONGRESS

U.S. Senator Patty Murray and Congressman Rick Larsen teamed up to introduce legislation in the Senate and House of Representatives that reauthorizes and expands the Northwest Straits Initiative.

"The Northwest Straits Initiative is a highly successful grassroots conservation effort that has consistently produced excellent work to protect and restore the natural marine habitat of the Northwest Straits," said Senator Murray. [Read more...](#)

PORT GARDNER DERELICT CRAB POT REMOVAL

After weeks of weather delays, crab pots were removed from the Port Gardner area in early May. Kathleen Herrmann and Jared Bond, staff and chair of the Snohomish MRC, and Ginny Broadhurst, Northwest Straits Commission director, accompanied a team from the Everett Herald out with the crew of the R/V Surveyor II to see the work. The crew targeted a high-density area of derelict crab pots and removed 143 of them for this project. Ninety-nine large, healthy crabs were found in the pots and released along with some dead ones that were returned to the water.



BEACH SEINING AT CHUCKANUT MARSH



Whatcom MRC members and other volunteers gathered early on a rainy spring morning to do some beach seining and netting of young fish at Chuckanut Bay, where a culvert was replaced with a lovely bridge to improve access for fish to the marsh.

Beach seining on May 5 found: 6 Chinook, 245 chum and 14 sculpins. In the adjacent salt marsh 62 coho and 62 sticklebacks were caught by dip net. Chris Fairbanks of the MRC said that monitoring before and after this culvert removal has shown a big increase in use of the

marsh by Chinook, coho and stickleback. More complete information will be available in the MRC's final project report due next month.

Northwest Straits Foundation Update

FOUNDATION RECEIVES FUNDING

The Northwest Straits Foundation received \$13,000 from the Sea World Busch Gardens Conservation Fund and \$15,000 from the Department of Natural Resources Restoration Program to remove derelict fishing nets from Puget Sound. Removals will target high priority areas in North Puget Sound.

The Foundation also received \$86,000 from the Department of Fish and Wildlife to remove derelict crab pots from Puget Sound. This funding is made possible through fishing license crab endorsement fees. Removals will focus on areas where high rates of lost crab pots are associated with recreational crab fishing.

OLYMPIA OYSTER IDENTIFICATION TRAINING

Olympia oysters perform important ecological functions in local marine waters, including serving as a filter to improve water quality and providing habitat for local invertebrate populations. The first steps to rebuilding native oyster habitat are to find remnant populations and identify the right habitat conditions for them to thrive.

Free workshops are being offered this spring and summer to teach people how to find and identify Olympia oysters, assess habitat conditions and report these findings to the state in order to better understand the current distribution



of this important native species. Four dates and locations are scheduled, registration is required. [Click here for more information.](#)

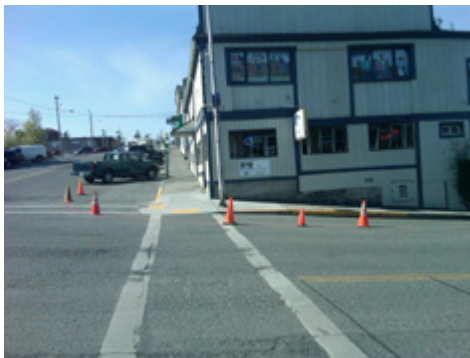

With grant funding, the San Juan MRC and the Town of Friday Harbor are installing a rain garden demonstration project along Spring Street. Its purpose is to act as a real-world experiment to see if larger application of this technology can filter the runoff from the mostly paved core of the town. An added benefit is that it will help make downtown Friday Harbor more attractive. This project

demonstrates how a community can experiment with a promising, affordable technology, and evaluate the results to inform future decisions. [More...](#)

THE NWSC 2011 BUDGET: UPDATE FROM GINNY BROADHURST, NWSC DIRECTOR

This week we heard the news that we didn't want to hear about our budget: there's no federal funding coming to the Northwest Straits Commission for our upcoming fiscal year that starts in July. Hope for the best but prepare for the worst has been our strategy. We've got contingency plans in place that allow some unspent funds from 2010 to be used to maintain staffing at the Commission and our 7 MRCs. We also just got the good news that we will receive \$400,000 in EPA funding to help. We're still at less than half of our usual \$1.6 million budget, but this allows us to keep base operations going and leverage other funds. Thanks to everyone for your show of support and your commitment to keep us moving forward. We have a lot of strong partners, including support from Senator Murray who provided the statement below. Many thanks, Ginny

Statement from Senator Patty Murray:

I was proud to work with Congressman Jack Metcalf in 1998 to help create the Northwest Straits Commission in order to make sure that community input and grassroots participation helped shape efforts to conserve our marine ecosystems in the Northwest Straits. And thirteen years later, we can say with certainty that it has been a tremendous success, it is a worthwhile investment—and that it needs to continue.

The work conducted by the Commission, not only with projects on the ground, but also through advocacy, has made an extraordinary positive impact throughout Washington state. So I was extremely disappointed when the Department of Commerce did not include funding for the Northwest Straits Commission in their fiscal year 2011 spend plan. I have worked for years, with Administrations of both political parties, to secure funding for this vital organization. Budgets are extraordinarily tough

in both Washingtons, but we owe it to our state and to our country to continue investing in projects that work.

While I am deeply disappointed about this funding shortfall, I would like to work with the Northwest Straits Commission, the Administration, the State of Washington and other leaders on marine policy in Washington state to find a path forward for the Northwest Straits Commission. It's time for us all to come together and redouble our efforts to make sure this great work continues into the future.

In 2004, an independent national evaluation panel led by Bill Ruckelshaus confirmed that the mission of the Northwest Straits Commission was worthwhile and encouraged continued support. And I will be working to bring together another panel of experts in Washington state to discuss options moving forward. Because I know that the work of the Northwest Straits Commission is important to our economic and environmental future in Washington state, and that by working together, I am certain we can find a successful path forward.

CONGRESSMAN RICK LARSEN JOINS DERELICT GEAR REMOVAL CREW



Congressman Rick Larsen boarded the F/V Bet Sea on June 9 to observe a derelict net removal operation at Alden Bank. Accompanying Larsen were Ginny Broadhurst, Director of the Northwest Straits Foundation and the Commission, KPLU reporter Bellamy Pailthorp, Jeff Callender of ConocoPhillips, and Don Waage of the National Fish and Wildlife Foundation.

The field trip demonstrated the importance of a \$100,000 grant to the Northwest Straits Foundation, awarded to remove 90 derelict gillnets from Whatcom County marine waters. This funding was awarded by the ConocoPhillips' SPIRIT of Conservation Migratory Bird Program, a partnership between ConocoPhillips and the National Fish and Wildlife Foundation.

More than 500 derelict gillnets remain in Whatcom County waters, entangling and killing thousands of marine animals and destroying underwater habitat. The Northwest Straits Foundation has removed over 3,900 derelict nets from Puget Sound, including hundreds from Whatcom County. [Read more...](#)

CLIMATE CHANGE AND FISHERIES

On May 25-26, the University of [Washington Climate Impacts Group](#) and West Coast Sea Grant agencies held a climate change/fisheries workshop in Seattle, convening 60 invited scientists,

Using a framework that is being tested elsewhere, including Australia, participants were charged with assessing the vulnerability of ecologically and economically important marine species to a changing climate. FRIDAY HARBOR RAIN GARDEN



Last month we reported on a demonstration project along the main route through Friday Harbor on San Juan Island. The rain garden is now planted, creating a lovely space and capturing polluted runoff at the same time. Like any garden, it will take time and care for the plants to grow and fill in. Safety concerns are being addressed with a new handrail or safety barrier, and an interpretive sign will be added soon. The rain garden will also be monitored to accurately understand the water treatment that it does provide and whether, on a larger scale, this could be a

viable way to provide cleaner freshwater to Friday Harbor.

Northwest Commission Meeting Highlights

ELWHA RESTORATION PROJECT UPDATE

Dean Butterworth of the National Park Service gave a presentation on the Elwha Restoration Project. The agency is working closely with the Lower Elwha Klallam Tribe and other partners to restore the

Elwha River and its ecosystem, with removal of the Glines Canyon and the Elwha dams slated to begin in September 2011. These actions will benefit salmon and trout that have been physically blocked from historic spawning grounds. [Click here for the website with more information on the project.](#)

NATIONAL OCEAN POLICY LISTENING SESSION

On June 27, Caroline Gibson attended the National Ocean Council 'listening session' in Ocean Shores. One of 12 National Ocean Council 'listening sessions' took place in Ocean Shores. Locally hosted by the Quinault Indian Nation and neighboring coastal tribes, the event drew more than 100 people from state and federal agencies, tribes, businesses and organizations to comment on draft plans for [ocean policy-related actions](#) over the next two years. Many remarked that

Washington state is leading some of the most progressive ocean policy efforts in the country, including recent legislation to better respond to oil spills.

Senator Kevin Ranker and Makah Tribal Chair Micah McCarty, who serve as federally-appointed advisors to the National Ocean Council, were among the invited experts who highlighted the Northwest Straits Commission as a model for ecosystem restoration and stewardship. Clallam County Commissioner Mike Doherty presented thoughtful public comment on the value of Northwest Straits and Coastal MRCs to their counties and communities; Terry Williams, Tulalip Tribes, stressed the need to include Puget Sound when carrying out national policy objectives. An impressive array of participants also included Representative Norm Dicks, Senators Hatfield and Hargrove, Eric Schwaab, John Stein and Will Stelle from NOAA, and Fawn Sharp, Quinault Indian Nation.

REAUTHORIZATION BILL PASSES SENATE COMMITTEE

U.S. Senator Maria Cantwell helped secure committee approval for the Northwest Straits Initiative's reauthorization bill (S962). The legislation was recommended out of committee and now heads to the full Senate for consideration.

The Northwest Straits Marine Conservation Initiative Act, introduced by [Senator Patty Murray](#) in May and cosponsored by Senator Cantwell, builds upon 14 years of successful marine restoration and protection efforts by reauthorizing and expanding the Northwest Straits Commission. The MRC collaborated with the City of Bellingham and GIS analyst Suzanne Shull, Padilla Bay NERR, modeling the system after the City's award-winning CityIQ map viewer.



Sound IQ presents nearshore data in "composite" maps that combine multiple data layers such as forage fish spawning beaches, eelgrass beds and shoreline hardening features. The system will be showcased at the 2011 Salish Sea Ecosystem Conference in a Data Fair on Web-based Ecosystem Tools.

SENATOR MURRAY CALLS TOGETHER LEADERS FOR NWS INITIATIVE



Thank you to Senator Murray and those who participated in the meeting August 18 on the future of the Northwest Straits Initiative. We had a productive meeting with the Senator, Washington state Senator Kevin Ranker, local elected officials, and agency, tribal and Northwest Straits Commission leaders on the need to secure stable funding for the Northwest Straits Initiative. Bill Ruckelshaus reminded the group of the unanimous support for continuing the work of the Initiative from the national panel who conducted a form review a few years ago. Bill said, "Bear in mind the assets of the people who are engaged. If we allow that infrastructure to float away it would be a terrible tragedy."

Jerry Masters, NWSC Chair, praised Senator Murray for "her continuing commitment to stewardship of our environmental resources and her demonstrated leadership by directly engaging citizens for solutions at the local level. Senator Murray inspired others in the room to do the same within their respective agency, and tribal or local government."

We will continue to discuss possible funding solutions in the coming week with members of the group, and expect to reconvene by early October.

MORE ON FORAGE FISH...

Many of the birds, seals, porpoises and other marine wildlife that we are seeing close to shore this month are gorging on schools of Pacific sand lance, and an exciting project to obtain new information about this important prey species is wrapping up. With funding from the Northwest Straits Commission, a team of researchers from across the region, led by geologist Dr. Gary Greene and biologist Dr. Tina Wyllie-Echeverria, have been studying sand lance in deep waters of the San Juan Archipelago. Extensive data are now being analyzed, and results will be presented to the Northwest Straits Commission in September and at upcoming conferences.

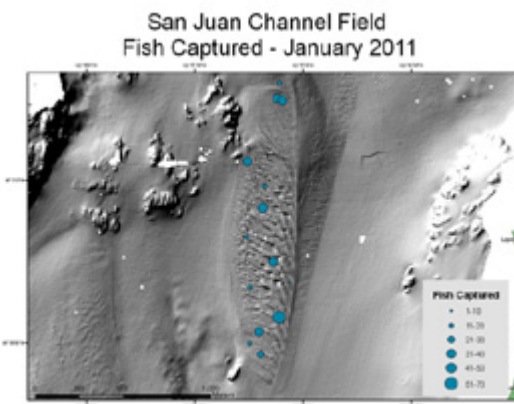


Photo: Sampling indicated a large number of sand lance in the bedform during winter months. (Click on photo to enlarge)

Over the past year, the project team conducted 12 research cruises, sampled 38 sand wave fields and other bedforms, analyzed 1,027 fish, and studied the burrowing behavior of sand lance in aquaria. Among innovative technologies used in this project were an acoustic multibeam echosounder and a

U.S. Geological Survey eyeball sediment camera, which produced high resolution images of seafloor sediments that harbor sand lance when they are not swimming.

MRC Happenings

BEACH SEINING IN SKAGIT COUNTY

More than 25 enthusiastic volunteers participated in a community beach seine survey at Ship Harbor, near the Anacortes ferry terminal, on August 8. The event, sponsored by Western Washington University/Shannon Point Marine Center, the Skagit MRC and Skagit County Beach Watchers, proved a wonderful opportunity for people of all ages to spend an afternoon in the sunshine mucking about in the shallows. Hosted by MRC and Shannon Point faculty member Paul Dinnel, this survey is the first in a series to be conducted during the 2011-2013 field seasons.



Dr. Jude Apple and student interns from Shannon Point helped ensure that everyone had a turn measuring and counting the tiny starry flounder, English sole, surf smelt, sculpins, and salmon smolts (one Chinook and two coho) that were caught. Beach seining is fun, and it's also a useful means of documenting nearshore marine life during a given time of year. As with other surveys carried out by MRC members and project partners, all fish were released unharmed.

MRC PROJECT HIGHLIGHTS

The end of June marked the close of a two-year grant period for MRCs, and Commission staff have been reading all of the final reports on projects. We already know that MRCs do great work, but at the end of each grant cycle it's easy to be blown away by the accomplishments.

A few recent highlights:

- Clallam MRC has trained 134 volunteers in oil spill response.
- Island MRC has completed an aerial and videographic eelgrass survey in collaboration with a local pilot.
- Jefferson MRC produced eye-catching new outreach materials on soft shore armoring.
- San Juan MRC installed a new rain garden and conducted community outreach on the project.
- Skagit MRC documented an increase in native Olympia oysters at their restoration sites.
- Snohomish and Island MRCs advanced the Conservation Action Planning process for a Port Susan Marine Stewardship Area.
- Whatcom MRC documented hundreds of juvenile salmonids at Chuckanut Village Marsh, site of a restoration project completed last year.

WELCOME NEW MRC MEMBERS

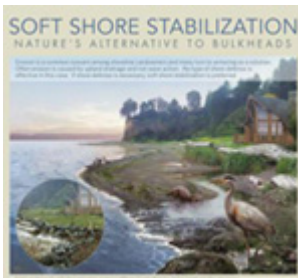

CLALLAM MRC READY FOR ELWHA DAM REMOVALS

Last week, dam removal operations started on the Elwha and Glines Canyon dams on the Elwha River. Clallam MRC recognized some years ago that the removal of the two Elwha River dams would likely benefit wildlife in the Strait of Juan de Fuca. Moreover, they knew that the removals would provide a unique opportunity to study the habitat effects in detail. They have been collecting information about eelgrass, macro-algae, sediments, and fish populations for at least five years in partnership with contractors, volunteers, the local community college, and a nonprofit organization.

The Clallam MRC gathered information near the Elwha River, where they suspect sediments released will begin to restore habitats, and from parts of the Strait not expected to receive sediment from the Elwha River. "With all our work in the marine nearshore, the MRC has been preparing for these dam removals for a long time", said Andrew Shogren, chair of the Clallam MRC. "We're interested to see how the habitat changes and finally put all this data we have collected to use. It's

an exciting time to be in Clallam County.”

A GREAT FORAGE FISH SYMPOSIUM!

Commission staffer Caroline Gibson participated in an historic gathering of over 4,200 fisheries experts from around North America, as one of four organizers of the highly-successful symposium on forage fish at AFS 2011 (<http://afs2011.org/>) in Seattle. Approximately 80 people turned out to hear the impressive lineup of 27 presentations showcasing research and policy efforts here and around the globe, including a keynote address by Dr. Ellen Pikitch, professor at Stony Brook University and Chair of the national [Forage Fish Task Force](#). Presentations included those by MRC member and project partners Tina Whitman, Gary Greene and Jamey Selleck. Great work is happening in this region; on seabirds stuffing their bills with sand lance at Protection Island, NOAA trawl surveys of all Puget Sound basins, genetic analyses of surf smelt, effects of hypoxia on the vertical movement of forage fish in Hood Canal, protecting intertidal habitats here and in British Columbia, and much more. Dr. Adam Summers of Friday Harbor Labs gave an award-worthy comic demonstration of burrowing sand lance, part of the recent deepwater sand lance project funded by the Northwest Straits Commission. WEST COAST GOVERNORS' AGREEMENT MARINE DEBRIS WORKSHOP



Northwest Straits Commission Director Ginny Broadhurst participated in a three-day final workshop of the Marine Debris Workgroup, created under the West Coast Governors' Agreement on Ocean Health. The Marine Debris group, with representatives from California, Oregon and Washington, completed a final strategy document and discussed options for creating an ongoing coalition to carry out the actions needed to address marine debris threats

and impacts all along the Pacific coast. [Click here for group members.](#)

DISSOLVING BEFORE OUR EYES: THE ACIDIFICATION OF OUR OCEANS

Roughly one-third of the 70 million tons of CO₂ we release into the atmosphere every day is absorbed by the oceans, where it reacts with seawater to form carbonic acid. As a result, our oceans are becoming literally corrosive. At that current rate of emissions, ocean acidity will more than double by 2100, enough to dissolve the shells and skeletons of key marine organisms such as corals, oysters, and pteropods (an important source of food for young salmon). Marine ecosystems are already suffering, and some of the most drastic changes are happening right here in our local waters, affecting iconic Northwest fisheries and marine life. Our conversation will explain the science, the environmental and economic consequences, and the political opportunities and challenges of ocean acidification. Brian Baird, former United States Representative from Washington's Third Congressional District, and Dr. Richard Feely, Senior Scientist, NOAA Pacific Marine Environmental Laboratory, will join us as we explore this important issue. 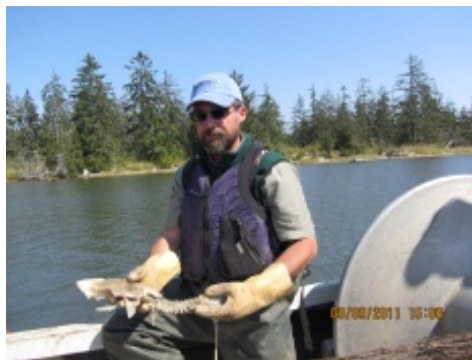

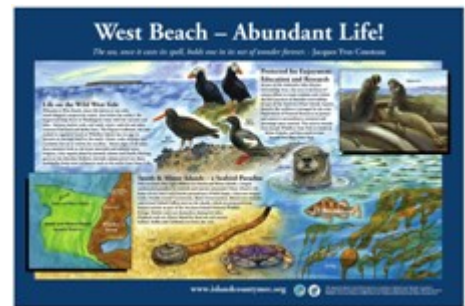
DISSOLVING BEFORE OUR EYES: OCEAN ACIDIFICATION SYMPOSIUM

Northwest Straits Foundation Update

OLYMPIA OYSTER REBUILDING

The Northwest Straits Initiative has taken a bigger plunge into native oyster rebuilding in partnership with National Fish and Wildlife Foundation, Washington Department of Fish and Wildlife, [Puget Sound Restoration Fund](#), the Swinomish, Samish and Jamestown S'Klallam Tribes and several Marine Resources Committees. Several training workshops were organized this past summer to train MRC members and others to identify Olympia oysters in the field and engage the powers of the MRCs in identifying suitable habitat. This is not quite as easy as it sounds, as Olympia oysters are cryptic in appearance and with regard to their habitat requirements, and not nearly as showy as their cousin the Pacific oyster.



Other items on the 2011 native oyster agenda included genetic analysis of potential broodstock locations, the development of a preliminary enhancement plan for several North Sound locations, and, broodstock collection and seed production for 2012 enhancement. Particular care is being taken with seed production to ensure genetic diversity. To this end, Puget Sound Restoration Fund is using conservation protocols co-developed with Washington Department of Fish and Wildlife and University of Washington.

The Change Analysis Report, which describes a remarkably detailed analysis of what's changed along Puget Sound's shorelines over the past 150 years, is now available online. This impressive body of work is already being used to inform many restoration projects, and is a foundational element of work by the Puget Sound Nearshore Ecosystem Restoration Project (PSNERP). One major finding is the dramatic simplification of our shorelines due to human alterations, including a 41 percent decrease in total delta length, and disappearance of many embayments Sound-wide.

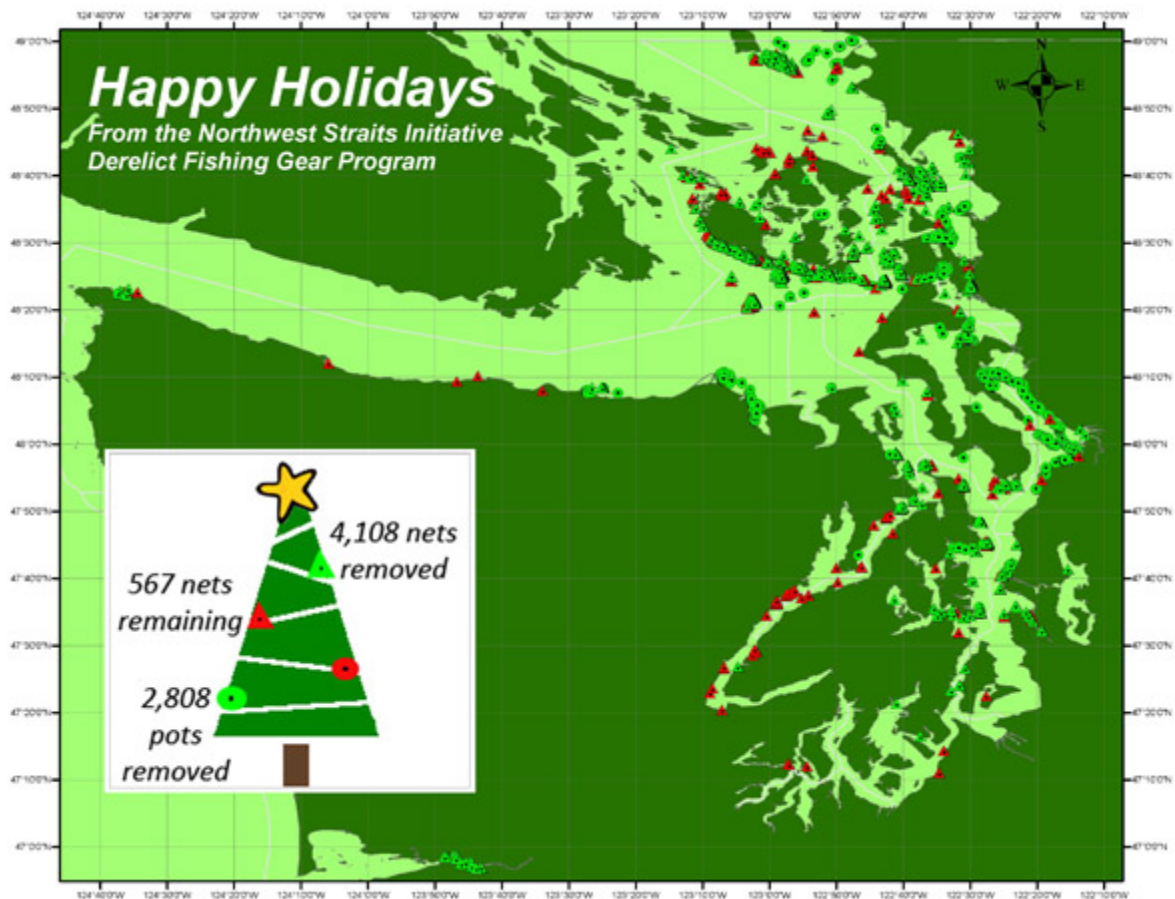

FIELD TRIP TO MAYNARD BEACH

ENGAGING WITH COUNTY GOVERNMENTS & THE ACTION AGENDA

Our first panel was comprised of Lovel Pratt, Chair of the San Juan County Council; Mike Doherty,

Clallam County Commissioner; Angie Homola, Island County Commissioner; Phil Johnson, Jefferson County Commissioner and Gerry O'Keefe, Executive Director of the Puget Sound Partnership. The panel discussed the value of MRCs and the role of each in its county and regionally.

RESTORATION SAMPLER: SIZE DOESN'T MATTER

Restoration projects come in all shapes and sizes, and small-scale projects can contribute to the overarching goal of increasing habitat by restoring ecological processes. Small projects can also build toward cumulative benefits over a large area. This session highlighted three of the ongoing and recent nearshore restoration projects involving MRCs. Gabrielle LaRoche presented the Maynard Beach project in Jefferson County, Lenny Corin described the Cornet Bay project in Island County, and Chris Fairbanks shared results from fish-use monitoring following Chuckanut Marsh restoration in Whatcom County.

SUSTAINABILITY IN MARINE RENEWABLE ENERGY

Simon Geerlofs, Snohomish MRC member, did a great job of introducing the complex topic of marine renewable energy in this last session of the day. Jeff Ward, who serves on the Clallam MRC, described studies at Battelle to document effects of electromagnetic fields on Dungeness crabs and other local marine species. Dr. Brian Polagye, a faculty member at UW College of Engineering, presented current research on the environmental effects of tidal energy systems. Brian noted that tidal energy projects are still in the experimental stages here and around the world.

ENVIRONMENTAL LEADERSHIP AWARD

Sessions on Saturday December 3:

GIS IN THE 21ST CENTURY

A trio of GIS experts demonstrated local, regional, and national web-based applications that are a great resource for MRCs and others doing nearshore projects. Tom Carlson, GIS Liaison with USGS, was a newcomer to our crowd, presenting US Topo for Washington and the recent incorporation of scanned historic quadrangles. Kathy Taylor of the Department of Ecology presented the Washington Coastal Atlas, and Suzanne Shull from Padilla Bay demonstrated the Island County SoundIQ system. This dynamic and informative session generated good questions, ideas and discussion.

DESIGNING EFFECTIVE EDUCATION AND OUTREACH PROGRAMS

This session, led by Northwest Straits Foundation staff member Tracie Johannessen, provided

context for MRC members involved in education and outreach by reviewing methods used by educators to design effective programs. Examples included a recent outreach effort focused on coastal landowners in Whatcom County presented by Stephanie Williams, an outreach proposal submitted by the Foundation and the Snohomish/Island MRCs for the Port Susan Marine Stewardship Area, and a new tool available from WSU Beach Watchers for community groups to engage in learning about and discussing water issues presented by Pat Pearson.

MRC INVOLVEMENT IN SHORELINE MASTER PROGRAMS

Cathy Lear, Clallam MRC staff, and Michael Adams, Jefferson MRC chair are in the thick of their county SMP updates. In this session they explained how and why MRC members should engage locally, and deftly walked session participants through real life experiences and examples of information/expertise that's needed and how local knowledge gets used. Although the process can seem overwhelming, SMPs provide a necessary framework for county policies around human uses of our shorelines.

LEADERSHIP DEVELOPMENT

Ian Jefferds, chair of the Island MRC, Jerry Masters, former chair of Snohomish MRC and Kit Rawson, former chair of San Juan MRC hosted a session on MRC Leadership. This was an opportunity to discuss challenges in leading an MRC, the importance of recruiting new members, the benefits and downsides of term limits and many of the other “nuts and bolts” issues that are part of MRC operations.

HOW TO FUND YOUR MRC

In this session, Ginny Broadhurst described previous and possible future funding structures for the MRCs, emphasizing greater reliance on local support for basic MRC work coupled with assistance from the Foundation for project funding. Joan Drinkwin provided a template for each MRC to develop a ‘case statement,’ which is a general overview of the mission, work and structure of an organization. Case statements are designed as tools to galvanize support and funding for the work of each MRC, and participants started draft case statements to take back to their respective MRCs to complete with assistance from Foundation staff as needed.

FORAGE FISH: NOW SURFACING

Caroline Gibson gave an overview of our Forage Fish Program, founded on 13 years of data gathering, mapping and more by the Commission, MRCs and project partners. Beginning with intertidal surveys, and continuing through workshops, symposia, and research on Pacific sand lance in deep water, the Commission and MRCs are expanding the knowledge base around forage

fishes and their role in Salish Sea ecosystems. One next step is the international Research Symposium on the Ecology of Forage Fishes to be hosted by the Commission at Friday Harbor Labs in 2012.

SECRETS IN THE SOUND

Dr. Florian Graner inspired us with a new version of his documentary film *Secrets in the Sound*, reminding everyone to share the positive aspects of Puget Sound and its beauty with others. Get your copy of the video at [Sealife Production's website](#).

THE ELWHA: A CULTURAL PERSPECTIVE ON RIVER RESTORATION

Robert Eloffson delivered an eloquent synopsis of the historical undertaking to restore the Elwha River by removing its two hydropower dams. Rob pointed out that the Lower Elwha Klallam Tribe never wanted dams or to see salmon runs disappear. Restoration has been decades in the making, involving legislation and extensive economic analyses.
